

Document Verification and Group Exercise Process (UPNHM)

(1) For the following positions SAMS shall be conducting and calling candidates for Group Exercise: -

(2) Group exercise for the above-mentioned positions shall be conducted within 4 days starting from **June 12, 2017**, in between eight panels

Note: A basic computer proficiency test shall be conducted for all the shortlisted candidates for the position of Rogi Sahayta Kendra Operator (RSKO-CP).

Instructions:

(1) Candidate shall report at the venue with his/her Call Letters and other testimonials indicated in Admit card/Call letters in support of qualifications and experiences at his/her given reporting time;

(2) Candidate shall have to report to the registration desk for document verification and panel allotment after reaching the venue;

(3) If the details of the candidate are in arrangement with his/her online form, he/she will be declared eligible for taking the test by giving him/her a panel number/room number. If NOT, then s/he shall be debarred from taking the test and thereby leading to cancellation of his/her candidature;

(4) If any candidates do not carry the original testimonials, he/she must carry at least attested copies of the same; otherwise his/her candidature shall be cancelled. It will be made mandatory for candidates to submit the photocopies of the documents at the time of registration. For candidates who are not carrying the essential documents, they shall be asked to sign on an undertaking agreeing that they shall not be allowed to appear in the group exercise process due to the absence of the documents;

(5) Candidates found eligible will be guided by **SAMS** resource person to the waiting lounge after completion of the registration process;

Process Summary

- (1) The GE process shall start with the Group formation.
- (2) Each Group shall consist of 8-10 candidates of the same position.
- (3) The Groups will be formed as per the serial number of the candidates on the Registration Sheet and shall be guided to their assigned rooms one by one after completing their registration process.
- (4) There will be eight panels (Group Discussion Rooms) which shall be conducting Group Exercise simultaneously.
- (5) Each Panel (room) will comprise of two Panelists, consisting of one from **SAMS** and other from **UPNHM**, Subject Matter Specialist.
- (4) Following the brief introduction of each member, group will be given a topic as per the prescribed Group Exercise topics format.
- (5) Each group shall be provided 55 minutes in which they have to discuss and come with a conclusion regarding the topic given.
- (6) Candidates shall have to give a small presentation on the sub topics. It will be mandatory for each candidate to speak on the topic for a minimum of 2 minutes and maximum of 3 minutes.
- (7) The Panelists shall assess each and every member in the group and also individually regarding their involvement in the discussion.
- (8) The panelists then will assign scores for the individuals on the Assessment Sheets based on their overall performance.
